- Fall Planning Meeting Minutes Julie: Minutes from the 10-22 meeting were reviewed and approved
- Treasurer's Report Amy:
 - Balance: \$1379.29
 - We have paid for Saturday Pond tote bags & donation to Lake Stewards of Maine
 - Members: 61 members. Member numbers are increasing
 - We discussed Pixie Williams' passing and time spent with her on the water
- Watershed Update:
 - Wildlife: Recently we have observed bald eagles, 2 loons, a merganser duck, mallard ducks, hawks, & turkeys
 - Resource: The Merlin app from Cornell University helps to identify birds
 - Dam: John Ywoskus is the new Saturday Pond dam keeper.
 - o Ice-Out: April 12, 2023
 - Thompson Lake Environment Association Survey: On May 19-20, TLEA volunteers will survey the 35 mile Thompson Lake Watershed to identify erosion and drainage issues. The SPWA survey was done with Department of Environmental Protection in 2009.

 may have a video that we can use during the annual meeting. Julie will check for
 availability.
- NH Loon Preservation Society: Sue distributed loon brochures from the NH Loon Preservation Society

- Wake Boat Restrictions:
 - Wake Boat Restriction Legislation Update LD 693: Audubon staff felt hearing went well for possible legislation; Amy did not feel that.
 - Status: Ellen will find out status of LD693. Then members will meet again to discuss next steps
 - Education Page: Susan will write an educational page covering wake boats, loons, and invasive plants. Amy will distribute it on docks with the July 4 parade announcement.
