- Ground Rules for Zoom Meeting Susan Haber: Susan reviewed the rules for the Zoom meeting
- Treasurer's Report Amy Brown: Amy reviewed the Treasurer's Report
  - o Balance: \$1374.44
  - Upcoming Bills: There is one more water test that will be paid for
  - Member Dues Paid: Last year, members paid \$690 for dues, this year, \$405 was paid.

- SPWA Annual Report for Fiscal Year 2021:
  - Pond Water Conditions
    - **Dam Keeper's Report:** Saturday Pond dam report from Dan Peaco dated 7/9/20:

"With all of the recent rains water is flowing over the planks in the spillway at a reasonable rate. There is brush, still, on the riprap of the dam and is scheduled to be removed by the end of July. The water gauge that has been promised by me to have installed is on order by the town and should be arriving shortly. This spring a small amount of brush and debris was removed from the spillway. Later, a call from Julie saying there was a log wedged in said spillway was promptly removed by me, but not before a nice picture was able to be taken and published in the SPWA newsletter. Otherwise, all seems good at the outlet of Saturday Pond. Sincerely, Dan Peaco"

- Water Testing Steve Markarian: Steve has tested the water 6 times this year; all readings were shallow; some larger boats are disturbing the water and causing readings to be lower than they should be
- Lake Monitoring for Invasive Aquatic Vegetation Sue LaFleur: Sue has attended a few LSM trainings; Sue has been out to survey the lake for invasive plants several times; no concerning plants seen to date (middle cove has young bladderwort; sent to state last year; not invasive); Amy, Julie, Robin, and Sue will continue to monitor lake
  - **Concern:** How do we make sure that visitors are checking their boats

- Pond Wildlife: This year, members have seen loons, eagles, osprey, muskrats, turtles, beaver, Canadian geese; loons and geese both nested, but no babies have been seen
  - Official Loon Count Robin Nureck: We have seen more, but the official loon count is 3.
